Hand wash sink was observed to be fully stocked.

All dry storage foods were observed to be above the floor and well organized.

During the inspection, it was observed that the three compartment sink has a raised floor sink. Although it is indirectly drained, the floor sink is raised by the use of wooden board pieces. These wooden pieces require to be sealed and fastened to the floor to prevent both rot and the drain from falling.

Please correct the above noted violations before the next routine inspection.
