Description/Corrective Action: Observed a dead cricket in the hall way of the restrooms. Food handler stated pest control has recently performed service on this building but no copies of pest control receipts were available on site. Violation: IMPROPER COLD HOLDING TEMPERATURE(S) [HSC 113996]

Description/Corrective Action: Temperature of the cold holding unit located to the right of the cash register was noted to be at 45°F. The milk and other liquid products in this unit were moved to the cold holding unit located behind it. Please make sure to keep this unit at or below 41°F and service if needed.

Violation: FOODS & EQUIPMENT NOT PROTECTED FROM CONTAMINATION [HSC 113980, 114025-114027]

Description/Corrective Action: Observed a ice cream scoop inside the reach in freezer unit. Food handler stated that this unit is for employee use only. Please label this freezer with a sign that reads "employee freezer."

General Comments:

All hand wash sinks were observed to be fully stocked.

Except for the above noted unit, all other cold holding units were holding temperatures below 41°F.

The restroom was observed to be fully stocked.
